### 1. Foreign teachers in short-term supplementary learning centers

### Background :

- ✓ 2018.2.08 Enforcement of talent recruitment and exclusive law In order to meet the needs of industrial development, short-term cram classes are newly added in Article 4, Paragraph 4, Item 2 of the Act in the case of a teacher with specialized knowledge or technology
- ✓ 2021.7.07 Amendment and promulgation of the Special Law on Talent Acquisition, which will also include the full-time foreign language teacher jobs under the "Work Qualifications and Examination Standards for Foreigners Engaged in Employment Service Act, Article 46, Paragraph 1, Paragraph 1 to Paragraph 6" in Article 4, Paragraph 4, Item 3 of the Talent Acquisition Law
- ► Basis of Application: The Ministry of Labor amended & promulgated

A minimum monthly salary of NT\$47, 971 should comply with the Article 8 of "Qualifications and Criteria Standards for foreigners undertaking the jobs specified under Article 46.1.1 to 46.1.6 of the Employment Service Act." Also meets one of the following qualifications:

- Participating in the production of works with international awards winning record.
- Has more than 4 years of working experience in foreign digital content industry and 2 years of teaching experience in international teaching institutés.

### **Full-time** foreign language teaching

At least 14 hours of teaching work per week and the following qualifications:

- Adult
- Graduated from Junior college or above
  The language course taught is the official language of the foreign teacher's passport nationality

## 4.Documents for hiring foreign teachers in Short-term Supplementary Learning Centers

#### **DOCUMENTS NEEDED WHEN APPLYING**

- 1. Application form
- 2. A copy of applicant's or responsible person's ID, company registration, business permit, etc.
- 3. A copy of the employment contract.
- 4. A copy of a list of employed foreign professionals, passport, or ARC.
- 5. A receipt of processing fees.
- 6. Other documents required by the Ministry of Labor.

VALIDITY PERIOD

Validity period can last up to 3 years. An extension is available.

**EXTENSION** 

Within 4 months prior to the expiration of the permit, apply for an extension to the Ministry of Labor, the extension period is up to 3 years.

### **5. Freelance Art Workers**

- Background:
- ✓ 2018/2/8 Enforcement of talent recruitment and exclusive law to improve the employment environment for arts and culture in our country, Article 10 of the Act for the Recruitment and Employment of Foreign Professionals stipulates that foreign professionals may apply for a work permit from the Ministry of Labor without the employer's application to work in the arts in our country.
- ✓ 2019/12/9 Added: those who have shown creativity and special skills in the film, television, and audio field must apply to engage in artwork in Taiwan
- Basis of Application: Announced by the Ministry of Labor
  The Amendment of Regulations on the Work Permit and Administration of the Foreign Professionals Engaging in Arts and Performing Arts
  Stipulate relevant work qualifications and permit management matters

### 6. Work content of freelance artists

		WORK CONTENT
Freelance Artwork	Performing arts and Visual arts	means engaging in creating, researching, investigating, producing, performing, promoting, teaching or sharing (such as workshop and lecture), panel judging or competing in the field of music (pop music not included), dance, arts, drama, environmental arts, and photography.
	Publishing	means engaging in cultural arts in graphic and text creation, commenting, literary agency, editing, translating, curating, or researching in the field of newspaper, magazine, and book publication.
	Movie, Broadcasting Television, and Pop Music	means engaging in cultural arts in creating, producing, performing, promoting, teaching or sharing (such as workshops and lectures), panel judging, agency, managing or technology in the fields of film, broadcasting, television, and pop music.
	Crafts	means engaging in creating or teaching in leather, ceramic, stone, glass, fiber (dying, weaving or knitting), wood, bamboo, paper, metal, paint or mixed media.

### **7. Qualifications for Freelance Artists**

Performing Arts and Visual Arts	<ul> <li>Shall meet one of the following job qualifications:</li> <li>1.Over 10 years of working experiences in the applied art field and with creative and outstanding performance.</li> <li>2.Master degree at home and abroad and over 5 years of working experiences in the applied art field, or PhD degree at home and abroad and over 3 years of working experiences in the applied art field.</li> <li>3.With creative and outstanding performance in the art field, and with certificates or recommendations issued by government institutions or stated-owned enterprises.</li> </ul>
2. Publishing	<ul> <li>Over 8 year of working experiences in publishing field, and meet one of the following job qualifications:</li> <li>1.Served as Chief Editor or Senior Manager of a major international news, media outlet, or publishing house.</li> <li>2.Awarded with one's country's most prestigious prize for a publishing-related field of literature and comic; or an international prize for same.</li> <li>3. Creative and outstanding performance in the publishing field, and holds certificates or recommendations issued by government institutions or stated-owned enterprises.</li> </ul>

### 9. Freelance Artists documents to prepare

- 1. Application Forms.
- 2. Passport or photocopy of the foreigner's ARC.
- 3. Original copy of the processing fee.
- 4. Relevant supporting documents which comply with the requirements .
- 5. Other documents required by the Ministry of Labor


**VALIDITY PERIOD** 

Validity period can last up to 3 years. An extension is available.

**EXTENSION** 

Within 4 months prior to the expiration of the permit, apply for an extension to the Ministry of Labor, the extension period is up to 3 years.

## 11.Application notes for short-term supplementary learning centers teacher and freelance artist

How to file	<ul> <li>1.Apply in person (Address: 10F, No. 39, Zhonghua Road Sec. 1, Zhongzheng District Taipei City)</li> <li>2.Send through Registered Mail (address same as above Receiver: Workforce Development Agency Foreign Professionals work permit application)</li> </ul>
Processing period	If the documents are complete and both the employer and the foreigner meet the qualifications and conditions set forth, 12 working days from the date the application is received.
Processing fee	NT \$ 500 per application.
Translation of Document	If the attached documents are in foreign languages, they should be accompanied by a Chinese translation.

## 2 Matters concerning work for adult children of Foreign Professionals

### 1.Work for Young Adult

### Background:

- ✓ 2018.2.08 Enforcement of talent recruitment and exclusive law. Considering the needs of foreign talent family reunion · Article 17 of the law stipulates that in the case of foreign professionals engaged in professional work in the country and holding permanent residency, their young adult child can apply for a personal work permit to the Ministry of Labor if they meet certain residence requirements. There are no restrictions on industry classification and work permit period.
- ✓ 2021.7.07 Amendment and promulgation of professional recruitment law includes specific foreign professionals and foreign high-level professionals as applicable objects (Amended to Article 15)
- ▶ Basis of Application: Announcement of amendments by the Ministry of Labor T Ministry of Labor Directions for Reviewing the Application under Article 15 and 26 Child over the Age of Majority of the Act for the Recruitment and Employment of Foreign Professionals 」 handling matters related to obtaining work permits for young adult of permanent resident foreigners

### 2. Qualifications for work of young adult and documents required

### **QUALIFICATIONS**


- ✓ Continually and legally reside in Taiwan for a period of 10 years and stayed in Taiwan for more than 270 days in each of those years.
- √ 14 years of age below upon entering Taiwan, stayed in Taiwan for more than 270 days in each of those years.
- ✓ Born in Taiwan, legally accumulated ten years of residence in Taiwan, and stayed in Taiwan for more than 183 days in each of those years.

### **Required Documents**

- 1.Application form.
- 2.Certificate of Conformity or any identification document that match with the residency requirement verified by the Immigration Department.
- 3. Photocopy of APRC of Parents
- 4. Photocopy of Passport or ARC of the applicant
- 5. Relationship certificate of Applicant with his or her parents
- 6.Original receipt of processing fee.

Processing period	It takes 12 working days from the date of application if the documents submitted are complete and the applicant has met the qualifications.	
Processing fee	NT \$ 100 per application.	
Translation of Document	If the attached documents are in foreign languages, they should be accompanied by a Chinese translation.

## 3 • Bachelor's Degree of the world's top universities: lexempted from work experience

## 1.Bachelor's Degree of the world's top universities - no work experience

### Background:

- ✓ According to the current regulations, foreigners in Taiwan who are engaged in specialized or technical work, must be a university graduate and have more than 2 years of work experience, and the monthly salary must comply with the standard salary range of NT\$47,971 as announced by the Ministry of Labor.
- ✓ 2021.JULY.07 Amended and Promulgated the Law on Professionals
  Recruitment. Article 4 of the Law stipulates that those who have obtained a
  bachelor's degree or higher from the world's top universities announced by
  the Ministry of Education, and who engage in specialized or technical work
  in Taiwan, do not need to have a certain period of work experience
- ➤ Basis for application: In accordance with the current Ministry of Labor's

  「Qualifications and Criteria Standards for foreigners undertaking the jobs specified under Article 46.1.1 to 46.1.6 of the Employment Service Act related to specialized or technical work regulations, employers shall apply to the Ministry for an employment license


### 1. New Labor Pension System Regulations For Foreign Professionals

#### **Employer's contribution**

Employers shall contribute no less than six percent of workers' monthly wages to individual labor pension accounts at the Bureau of Labor Insurance for workers who are eligible for the Labor Pension Act on a monthly basis (Including workers holding ROC citizenship, people from China, Hong Kong or Macao residents, foreigners who are permitted to reside permanently, and foreign professionals who are permitted to reside permanently).

## Employees contribute voluntarily

In addition to the mandatory employers' contribution, workers may contribute voluntarily additional sums, up to a maximum 6% of their monthly wages, to their pension accounts

### 2.Time Schedule

2018.02.08

"Act for the Recruitment and Employment of Foreign Professionals" comes into effect 2019.05.15

"Labor Pension Act" amended and promulgated

2021.07.07

"Act for the Recruitment and Employment of Foreign Professionals" **amended and promulgated** 

Foreign professionals who are hired to engage in professional work, and who have been approved for permanent residence by the National Immigration Agency, Ministry of the Interior

Foreign citizens who are permitted to reside permanently in accordance with the relevant provisions of the Immigration Act (Including foreign professionals )

Foreign professionals who engage in professional work, and who have been approved for permanent residence "in accordance with the provisions of this law" by the National Immigration Agency, Ministry of the Interior



In 2021, Article 14 of the "Act for the Recruitment and Employment of Foreign Professionals" added provisions for foreign professionals approved for permanent residence. In order to distinguish foreigners who have obtained permanent residence in accordance with the "Immigration Act" and use the new labor pension system, Article 22 of the "Act for the Recruitment and Employment of Foreign Professionals" stipulates that foreign professionals who have obtained permanent residence permits "in accordance with the provisions of this law" shall be included as applicable objects of the new labor pension system.

## 4 . Applicable to the new system of labor retirement for foreign professionals

### 3. Characteristics

Claim at 60

Seniority is calculated based upon the period during which the contributions to the pension have been made. If workers change jobs, their **Accumulated Pension** seniority can be combined in calculation and pension can be accumulated. Workers may also voluntarily contribute within six percent of their monthly wages to the labor pension. The amount of labor pension **Tax Deduction** voluntarily contributed may be deducted from the gross consolidated income of the year. The return rate generated from the utilization of workers' pension shall not be less than the **Guaranteed Rate** interest rate of a two-year fixed term deposit by local banks. In the event of any deficiency, the Treasury shall make up the shortfall. Workers aged 60 years and older, with seniority less than 15 years, may claim a lump-sum payment; those with seniority greater than or equal to 15 years may choose to claim

a lump-sum payment or monthly payments.

## 4 Applicable to the new system of labor retirement/fox foreign professionals

### 4.Claims

Workers aged 60 years and older

seniority < 15 years

seniority ≥ 15 years may choose

Seniority shall be calculated based upon the period during which the contributions to the pension have been made. If the seniority of a worker is interrupted, both his/her seniority before and after the interruption shall be combined in calculation.

a lump-sum payment

The principal and accrued dividends from a worker's individual labor pension account are claimed in a lump sum at one time.

monthly payments

The principal and accrued dividends from a worker's individual labor pension account are paid in fixed installments (quarterly). The amount of each installment shall be calculated based upon the life chart of annuity, average life expectancy, interest rate and other factors.
