

亞洲 · 矽谷 2.0 新創發展環境精進策略

Strategies to Upgrade Taiwan's Startup Ecosystem under Asia-Silicon Valley Development Plan v. 2.0

創新創業是亞洲 矽谷計畫的兩大主軸之一，推動四年來臺灣新創生態環境更加活絡，並獲世界經濟論壇（WEF）評為全球四大創新國。

Upgrading Taiwan's startup and entrepreneurship ecosystem was one of the two objectives of the Asia Silicon Valley Development Plan. Since the Plan was launched four years ago, Taiwan startup ecosystem has been increasingly thriving. And Taiwan was recognized as one of the world's four super innovators by World Economic Forum (WEF).

未來四年國發會、經濟部、科技部等 13 個機關，將投入百億元共同推動創新創業發展，強化協助新創出場（上市櫃或併購）、促成企業對新創投資（CVC）及加速拓展海外市場，並透過國家新創品牌「Startup Island TAIWAN」向國際發聲，以培育更多能引領臺灣新經濟產業發展的指標型新創。

In the next four years, National Development Council (NDC), Ministry of Economic Affairs (MOEA), Ministry of Science and Technology (MOST), as well as some other ministries, will allocate their budget up to NT\$10 billion to upgrade Taiwan's startup & entrepreneurship ecosystem, and to foster more top startups that would spur Taiwan's economic growth. The strategies include providing assistance with startup exits (e.g. IPO on stock/OTC market or M&A), facilitating corporate investments in startups (CVC), and expanding into global markets. Further, the country's national startup brand, Startup Island TAIWAN, was launched under this Plan. When Taiwan startups expand into global markets in the future, the brand will be presented as a unified image for them.
